Early Detection Service and Prevention Education:

HCB2 increased their medical center partnerships from eleven free clinic and community health center sites to fifteen sites in 2023. HCB2 funds colorectal cancer screening to medically underserved and uninsured individuals across Virginia. HCB2 purchases FIT screening kits for patients and testing strips for medical staff to facilitate the screening of patients. Educational resources for clinics and their patients are also provided as well as staff training and technical support. Over 6,500 patients have been screened in a timely manner for colorectal cancer since the program's inception in 2017 due to HCB2's Free Clinic FIT Screening program.

Colon Health Education and Support Services:

HCB2 continues to provide education and resources through both in-person and virtual events in partnership with community groups and employers. Providing various educational resources to engage people in a deeper level of conversation about colon health and help people move from awareness to action is a large focus of our community education. Hitting Cancer Below the Belt's Junior Board consisting of high school students has expanded from six area high schools to eight high schools throughout the country. The group continues to meet monthly through Zoom meetings. The Junior Board members are interested in educating and inspiring their peers and community in an effort to improve colon health and prevent young people's diagnosis of colorectal cancer. The members help in the planning, creation of content, and marketing of messages and activities to better reach the Generation Z community. This generation of young people are 2x more likely to be diagnosed with colon cancer and 4x more
